# Character Education in Islamic Sufism Perspective

In everyday life, individuals are taught to recognize the signs of God's greatness around them and reflect on

existential meaning. The practice of dhikr and meditation can help create a deeper connection with things of a spiritual nature and guide individuals to live a life of greater purpose.

The application of Sufism-based character education also includes the development of humility and self-control. Individuals are taught not to be arrogant and to be humble towards others. They are also trained to control destructive passions and emotions, thus making them better able to face challenges and conflicts with a calm and wise head. Furthermore, Sufism-based character education teaches individuals to behave justly and practice forgiveness. Justice is essential in Sufism; individuals are trained to treat everyone fairly. In addition, forgiveness is a valued value in Sufism-based character education, creating individuals who are ready to forgive the mistakes of others, thus creating peace and better relationships in society.

This creates more positive relationships in society and reduces conflicts between individuals. Practicing dhikr and meditation in Sufism also helps individuals develop a sense of inner peace so they are better prepared to deal with stress and pressure with patience (Isgandarova, 2019; Subandi, Chizanah, & Subhan, 2022).

Applying Sufism-based character education also promotes the importance of honesty and integrity in daily interactions. Honesty is a highly valued moral principle in Sufism, creating individuals who behave honestly in Word and action. Sufism helps individuals appreciate the importance of integrity in their character to become individuals who can be trusted and respected by others. In addition, the application of Sufism-based character education also includes the development of moral courage. Individuals are taught to know what is right and be willing to stand firm for moral and ethical principles, even under pressure or challenge. The practice of self-introspection (*muhasabah*) helps individuals strengthen their moral courage to speak and act according to the ethical principles they profess.

Applying Sufism-based character education in everyday life also involves the concept of wisdom. Individuals are taught to make wise decisions and consider the moral implications of their actions. Smart decisions result from deep reflection. Furthermore, in character education, activities applying Sufism-based approaches promote social justice values. Justice is an essential principle in Sufism, and individuals are taught to treat all people fairly, regardless of social status, ethnicity, or background. Sufism helps individuals. Sufism allows individuals to be in a more inclusive and just society.

Applying Sufism-based character education also connects individuals with the concept of acceptance and tolerance of differences. It creates a more inclusive, just, and tolerant society. Furthermore, the application of Sufism-based character education teaches individuals to behave responsibly. They are trained to recognize their responsibility to themselves, their culture, and the environment. This creates an individual who is more caring and responsible towards the world around him.

In the context of Sufism-based character education, applying moral and ethical values also includes the concept of social solidarity. Individuals are taught to work together to achieve more significant goals and help those in need. Sufism practices such as *zakat* (charitable donations) and *sadaqah* became a means of sharing wealth with the less fortunate, creating a more just and caring society (Faizin, Karimullah, Faizal, & Lubis, 2023; Mittermaier, 2014; Singer, 2006). In

addition, the application of Sufism-based character education also teaches individuals to control their passions and destructive emotions. Self-control is an essential component in forming a moral character so individuals can avoid behavior harming themselves or others.

Applying Sufism-based character education in everyday life also includes another critical aspect: maintaining harmonious relationships with fellow human beings. It consists of an emphasis on the importance of communicating well, listening attentively, and responding with empathy to the needs and feelings of others. These practices create better relationships between individuals in society, reduce conflict, and increase understanding among fellow human beings.

The application of Sufism-based character education also includes values such as social care. Individuals are taught to be more sensitive to the suffering and needs of others. They are trained to provide help and support to those in need, either in the form of concrete actions or through charitable donations. This practice creates individuals who are more concerned and active in improving social conditions and people's well-being. Furthermore, in Sufism-based character education, applying moral and ethical values also includes the principles of truth and integrity. Individuals are taught to speak and act honestly and follow moral directions in all their lives. This creates individuals who can be trusted and respected by others.

In applying moral values in everyday life, individuals are also taught to reflect on their actions and practice self-introspection (muhasabah). This practice helps individuals understand and improve themselves and better appreciate their actions' impact on themselves, others, and society. Applying Sufism-based character education also includes accepting and tolerating and tolerating differences. Sufism teaches that differences are a gift of God and individuals should be open to different views and beliefs. The practice of dhikr and meditation helps individuals to develop a sense of tolerance and understanding towards others, which creates a more inclusive and peaceful society.
